Connie Langhorst – 331 Meadow Wood Dr.

Q: Are they still not cutting on Meadow wood drive?

A: Ben Snyder explained it was decided not to maintain trails due to expense. Will cut the area that is common between homes and to the back edge of the woods and that is it.

Bernie Murphy – 57 Rustic Ridge

- **Q:** Speeding? Any options on available humps or bumps? Bernie would like to see speed humps would that be legal.
- **A:** Stephen DiGioia responded that we have not investigated this since there was much opposition to this at last year's Annual Meeting. The Board will ask the Boro about the possibilities of installed speed humps in the plan. Ben Snyder also explained that this is an issue the Board cannot control and to call the Plum police dept. and complain about the speeding. There is strength in numbers.

Comment

The FedEx guy flies through the neighborhood! I called FedEx to complain and called the bus garage with School bus numbers that are also speeding in the plan.

Q: The 2019 – 2020 financial review is less than \$1,000 which is down from previous years. Is this correct?

A: Stephen DiGioia - Yes, it is! Should be around \$700 - \$800 per year moving forward.

Q: Instead of speed bumps could we do an extra stop sign instead?

A: Stephen DiGioia - We will talk to Boro.

Comment

You should go to the borough meetings to bring these items up. Our HOA is not the answer. It is the adults speeding as well as the kids. The Plum Boro Council meetings are where you need to go and voice your concern. Radar cannot be used and the only way to monitor speeding is to have the white lines for timing them or follow them and then they go slow because you are following them.

Q: Do we have an ordnance for cutting grass? It is an eyesore to those that live next door.

A: Dan Moriarity there is a borough ordinance that covers this issue. You can call the borough and they will start with a warning.
