The Chairman stated that all five directors being present, there was a quorum and it was in order to proceed with the business of the meeting.

The minutes of the December and January meetings were reviewed. One adjustment regarding the payment plan setup for one homeowner was made. It was also clarified that there are two payment plans; one for last year and one for the current year. Ms. Simpson-Greenberg made the motion to accept the revisions to the minutes and Mr. Soboslay seconded. Mrs. DiFrank then made a motion to accept the December and January minutes. There was discussion regarding legal issues and the status of the insurance policies. The Director's insurance is due to expire in May and the Liability insurance in June. We will revisit at the April meeting.

The yearly assessment letters are to be mailed on Friday April 1<sup>st</sup>. They will include the letter and a copy of the 2006 budget.

The Board received letters from Allegheny County stating that that the assessment values for the common areas were reduced to Zero.

The next order of business was discussing the landscaping situation. It was decided to review the current contract with Pivik Landscaping to check whether it is for one year or two. We will await information from Pivik Landscaping.

The board the reviewed the multiple bids for landscaping received after Mrs. Difrank and Mr. Soboslay met with the perspective contractors. Mr Barbieri had the lowest improvement bid. It was then discussed which contractor to use. The Board decided to wait until we receive word from Pivik Landscaping regarding the current contract's time frame. Mr Soboslay made a motion to award the contract to Mr. Barbieri for an amount not to exceed \$2000. Mr Greenberg Seconded and the motion passed 5-0.

The sign committee is scheduled to meet this Saturday at 10AM at the bottom of Rustic Ridge. It was discovered the part of the sign at the bottom of the street is rotting away.

The next order of business was the newsletter. It was decided to change the article about the Homeowner's Assocation existence. Mr Grasinger will re-write the first portion of the article. We also need an article thanking the Sign committee members for their hard work. Mr. Soboslay will include an article about improvements to the walking trails.

With no more business to discuss, the meeting was adjourned. The next meeting was scheduled to be April 11<sup>th</sup>, 2006.
